## Board of Director's Meeting: March 18, 2020

The Board of Directors unanimously adopted Ordinance 2020-02, which addresses Senate Bill 998 - The Water Shut-Off Protection Act. The District's newly adopted Delinquency Notice and Shut-Off Policy for Residential and Non-Residential Customers can be found on our website. Listed below are a few highlights for Residential customers:

**Billing:** The District is on a monthly billing cycle. Each meter will be read during the last week of each billing cycle and will be mailed the last day of each month.

**Due Date:** All bills or charges shall be due and payable at the District Office on the fifth (5th) of each month and shall be delinquent on the twenty-first (21st) of each month.

**Collection of Delinquent Bills:** Consistent with Government Code 61115(b) the District may determine it necessary to collect delinquent charges and penalties in the same manner as property taxes. The county tax collector shall include the amount of the charges and penalties on the tax bills for each affected parcel of real property and collect the charges and penalties in the same manner as property taxes.

**First Notice of Delinquency:** On the twenty-first (21st) of the month a Delinquency Charge will be assessed and a Notice of Delinquency will be mailed.

**Second Notice of Delinquency:** On the twenty-first (21st) of the subsequent month, all accounts over 30 days delinquent will be mailed a Second Notice of Delinquency. They will also be charged an additional Delinquency Charge.

**Final Disconnection Notice:** A Final Disconnection Notice will be mailed to all accounts that are over 60 days delinquent. Once this notice is delivered the account must be brought current to avoid disconnection.

**24-Hour Shut-Off Door Hanger**: A Door Hanger will be delivered to all accounts who have not paid by the due date on the Final Disconnection Notice. A \$15.00 Delinquent Notification Fee will be charged to the account. The account must be brought current to avoid disconnection.

The District offers several payment plans, such as the **Deferred Payment Plan**, the **Budget Payment Plan**, **Direct Payments (ACH)** and the **Alternative Payment Schedule.** We also accept Debit or Credit Card payments either over the phone or an online payment through our website.
