Operations & Maintenance and Capital Budgets for Fiscal Year 2017-2018:

The Board's Finance Committee presented both the O & M and Capital Budgets for Fiscal Year 2017-18. Following discussion, the Board unanimously adopted a balanced O & M Budget in the amount of \$910,165. The Board also adopted a balanced Capital Budget in the amount of \$901,500. The Capital budget includes funds to complete the ADA Improvement Project as well as construct approximately 1,200 feet of 24-inch mainline in Placer Road.

As we move into the summer months conditions will only get hotter and dryer; increasing the potential for wildfires. The State of California requires home owners to maintain 100 feet of defensible clearance around their homes. Here are a few items that will help you avoid a ticket and reduce the risk of loosing your home to a wildfire or losing your home owner's insurance this summer.

- * Create a Defensible Space of 100 feet around your home. It is required by law!
- * Create a "LEAN, CLEAN and GREEN Zone" by removing all flammable vegetation within 30 feet immediately surrounding your home.
- * Remove all dead leaves and needles from your roof and gutters.

PREPARE

- * Remove all dead branches overhanging your roof and keep branches 10 feet from your chimney.
- * Move your woodpile at least 30 feet away from any structure and remove all vegetation within a 10 foot radius from the woodpile.
- * Restrict lawn mowing and equipment use to cooler morning hours when lower temperatures and higher humidity reduce the risk of starting a wildfire.
- * Don't run engine if it is backfiring or overheating and don't leave engine idling unattended.
- * Hot engines are to be placed on bare ground only. Never place them on dry materials or grass that could ignite and start a large fire.
- * Be sure your equipment has a spark arrester. It is the law!
