# **Board of Director's Meeting:** February 19, 2020



Approval of Financial Statements for Fiscal Year 2018-19: Ms. Kayla Horton of the accounting firm Horton, McNulty and Saeteurn, presented the District's Financial Statements for Fiscal Year Ending June 30, 2019. The Independent Auditor's Report contains the opinions of the accounting firm regard-

ing their review of the District's financial position as of June 30, 2019 and the results of its operations and changes in net assets and cash flow for the year. The review was conducted in conformity with the accounting principles and systems prescribed by the State Controller's Office and State regulations governing Special Districts.

## **AC Pipe Testing**

Operator staff is planning to take the 5th sample of the District's AC pipe along Placer Road just east of the District Office. The District will be testing a total of six samples in different soil types within Centerville to evaluate the AC pipe's current condition as well as better

# Value of Water

Water is essential to life – both as a basic human need for survival and as an "ingredient" in almost everything we do, from food production to manufacturing to power generation.

You likely already appreciate that water is a precious commodity. For example, a human can survive at least three weeks without food, but can go only about three days without drinking water (or water-based liquid) before dehydration becomes a medical emergency.

Nonetheless, in the U.S., we commonly take access to quality drinking water for granted, and this water presently comes to most people in the U.S. at a very low cost—just cents per gallon.

Here is a little comparison just to put your water costs into perspective...

Local stores typically sell a 24-count case of 16.9 oz water bottles (Which is a total of 3.25 gallons) for \$9.98. This is \$3.07 per gallon.



Centerville CSD sells 748 gallons for \$1.04. This is \$0.001 per gallon. Even if you add in the Base Rate of \$28.75, Centerville's rate per gallon is \$0.039 per gallon.

When you pay your water bill, you are not only paying for the water you used, but also for all that it takes to treat and deliver it to your residence.

We look forward to continuing to provide a reliable, adequate supply of high quality water, at the lowest reasonable price, in an environmentally responsible manner to you each and every day!
