Proposed New Rates

The Board of Directors set a public hearing for June 19, 2024, at 7:00 pm ("Regular Board Meeting"). The Board Meeting will be held at the District Office located at 8930 Placer Road, Redding, CA. Please refer to the posted agenda for the most current meeting information. At the public hearing, the proposed rate increases will be presented and the public will be given an opportunity to comment. If adopted, the proposed changes will become effective July 1, 2024.

The following is a summary of the recommended adjustments:

- * A \$2.00 rate increase is proposed to both the current Base Rate and Water Availability Charge (WAC).
- * A \$.05 increase is proposed to the Consumption Rate.
- * A \$2.50 rate increase is proposed to the Zone A Base Rate Surcharge.
- * A \$.03 increase is proposed to the Zone A Consumption Surcharge.

Approval of 2022/23 Financial Statements

The Board of Directors unanimously approved the 2022/2023 financial statements presented by Ms. Kalah Horton with Horton, McNulty and Saeteurn. The Independent Auditor's Report contains the opinions of the accounting firm regarding their review of the District's financial position as of June 30, 2023 and the results of its operations and changes in net assets and cash flow for the year. The review was conducted in conformity with the accounting principles and systems prescribed by the State Controller's Office and State Regulations governing Special Districts.

Updated Capacity Charges Effective 5-1-24

In accordance with the District's Water Master Plan's Capital Improvement Plan Schedule, the Board of Directors unanimously adopted Resolution 2024-01 amending the District's Fee Schedule to include the updated Capacity Charges as shown below. The updated charges are effective 5-1-24:
