# Proposed New Rates

The Board of Directors set a public hearing for June 18, 2025, at 7:00 pm ("Regular Board Meeting"). The Board Meeting will be held at the District Office located at 8930 Placer Road, Redding, CA. Please refer to the posted agenda for the most current meeting information. At the public hearing, the proposed rate increases will be presented and the public will be given an opportunity to comment. If adopted, the proposed changes will become effective July 1, 2025.

The following is a summary of the recommended adjustments:

- \* A \$ 0.50 rate increase is proposed to both the current Base Rate and Water Availability Charge (WAC).
- \* A \$2.00 rate increase is proposed to the Zone A Base Rate Surcharge.
- \* A \$2.00 rate increase is proposed to the Zone A1 Base Rate Surcharge.

### Updated Capacity Charges Effective 5-1-25

In accordance with the District's Water Master Plan's Capital Improvement Plan Schedule, the Board of Directors unanimously adopted Resolution 2025-01 amending the District's Fee Schedule to include the updated Capacity Charges as shown below. The updated charges are effective 5-1-25:
